Have questions regarding Financial Aid?

Amberton University offers Federal Aid options as well as Private Education Loans. Students who complete the 2025-2026 FAFSA (Free Application for Federal Student Aid) may be eligible for federal aid for Summer 2025 - Spring 2026 sessions, through the Department of Education's Title IV Federal Student Aid. Amberton is participating in the Federal Pell Grant and Direct Loan programs. The FAFSA can be completed online at http:// StudentAid.gov, and place Amberton as a school of choice (our school code is 014925). For those who obtain a Federal Direct Loan at Amberton for the first time will visit http:// StudentAid.gov and complete the MPN, and Entrance Counseling. Beginning after December 2025, FSA will be prepared to allow students to complete the next year's 2026-2027 FAFSA for funding to begin July 1, 2026. Professional Licensure Statements

Marriage and Family Therapy

The purpose of the Master of Arts degree in Marriage and Family Therapy is to provide the graduate with a comprehensive knowledge of the functional areas of marriage and family counseling including but not limited to the nature of the counseling profession and an understanding of life span development, as well as cognitive knowledge of counseling theories, concepts and principles of concern to the counseling professional. The program can be completed through on-campus attendance as well as a mix of on-campus and on-line courses. It cannot be completed 100% online. Students who complete the Amberton University Master of Arts in Marriage and Family Therapy meet

the academic requirements for becoming a Licensed Marriage and Family Therapist in the State of Texas. Students should carefully review the current state requirements for changes and updates. The Texas State Board of Examiners of Marriage and Family Therapists provides clear guidelines and requirements to apply for a new licensure. Questions regarding licensure should be directed to the Texas State Board of Examiners of Marriage and Family Therapists, https://www.bhec.texas.gov/texas-state-board-of-examiners-of-marriage-and-family-therapists/index.html. No determination has been made as to whether or not this degree meets requirements in any other state besides Texas.

Clinical Mental Health Counseling

The Master of Arts in Clinical Mental Health Counseling is designed for persons interested in becoming Licensed Professional Counselors (LPC) in the State of Texas. The degree prepares graduates to work with individuals, couples, families and groups in community, social service, religious and private practice settings. The curriculum is comprised of sixty (60) graduate hours and includes a minimum of 300 practicum hours. No student may enroll in a practicum course without completing all other degree requirements. Students who complete the program meet the academic requirements for becoming Licensed Professional Counselors (LPC)

in the State of Texas. The program can be completed through on-campus attendance as well as a mix of oncampus and on-line courses. It cannot be completed 100% on-line. Students should carefully review the current state requirements for changes and updates. The Texas State Board of Examiners of Professional Counselors provides clear guidelines and requirements to apply for a new licensure. Questions regarding licensure should be directed to the Texas State Board of Examiners of Professional Counselors, https://www.bhec.texas.gov/texas-state-board-of-examiners-of-professional-counselors/index.html. No determination has been made as to whether or not this degree meets licensure requirements in any other state besides Texas.

School Counseling

The Master of Arts in School Counseling prepares students to satisfy academic requirements for the Professional School Counseling Certification in the State of Texas. Admission to this program is available only to those students who satisfy the Program Admission Requirements. The program is comprised of 48 graduate hours and includes a minimum of 160 practicum hours. Students completing this degree and passing the TExES examination for School Counseling are eligible for employment as a school counselor in an educational setting. Graduates will be counselors, academic advisors and advocates

who create conditions of academic achievement for children in public and private schools. The program can be completed through on-campus attendance as well as a mix of on-campus and on-line courses. It cannot be completed 100% on-line. Students should carefully review the current Texas Education Agency (TEA) requirements for changes and updates. TEA provides clear guidelines and requirements for certification. Accounting Degree

Requirements for the Certified Public Accountant (CPA) license vary by state and involve more than successful degree completion. Candidates for licensure need to satisfy other requirements, including but not limited to completing an application, paying a fee, passing licensure exams, and work experience.

The BBA/MBA Accounting degree meets the education requirements of the Texas State Board of Accountancy Public necessary to register for the Certified Public Accountant examination. The 150-credit hour dual program can be completed 100% online. Students who complete the Amberton University Bachelor of Business Administration in Accounting AND Master

Nursing Facility Administrator (NFA) Certificate

Students who complete the Amberton University Nursing Facility Administrator (NFA) Certificate meet the academic requirements for NFA Licensure in the State of Texas. Students should carefully review the current state requirements for changes and updates. Texas Health and Human Services provides clear guidelines and requirements to apply for new licensure. Background Checks

In Texas, the Texas Health and Human Services Commission (HHS) mandates background checks for various individuals working or residing in child care and residential settings, foster homes, and adoption agencies. These checks are designed to ensure the safety and well-being of children by identifying individuals with criminal histories or child abuse/neglect records. The Centralized Background Check Unit (CBCU) conducts these checks, including fingerprint-based and name-based criminal history checks, plus checks of state and national registries for child abuse and neglect and sex offenders. Background checks are required for applicants.
